Death Benefits - For deaths occurring October 23, 2001 through October 31, 2002

Weekly death benefits for beneficiaries are computed as percentages of the deceased's average weekly wage, which shall be taken as not more than the State's Average Weekly Wage (SAWW). The maximum weekly income benefits payable to <u>all</u> beneficiaries varies depending upon the deceased's average weekly wage. If the deceased's average weekly wage is less than the SAWW, the aggregate weekly income benefits payable to <u>all</u> beneficiaries shall not exceed 100% of the deceased's average weekly wage. If the deceased's average weekly wage is equal to or greater than the SAWW, the aggregate weekly income benefits payable to <u>all</u> beneficiaries shall not exceed 100% of the deceased's average weekly income benefits payable to <u>all</u> beneficiaries shall not exceed the SAWW, the

The following chart is an **EXAMPLE**. It represents the aggregate weekly income benefits payable to all beneficiaries of a deceased worker whose average weekly wage equals or exceeds the State's Average Weekly Wage of \$473.
